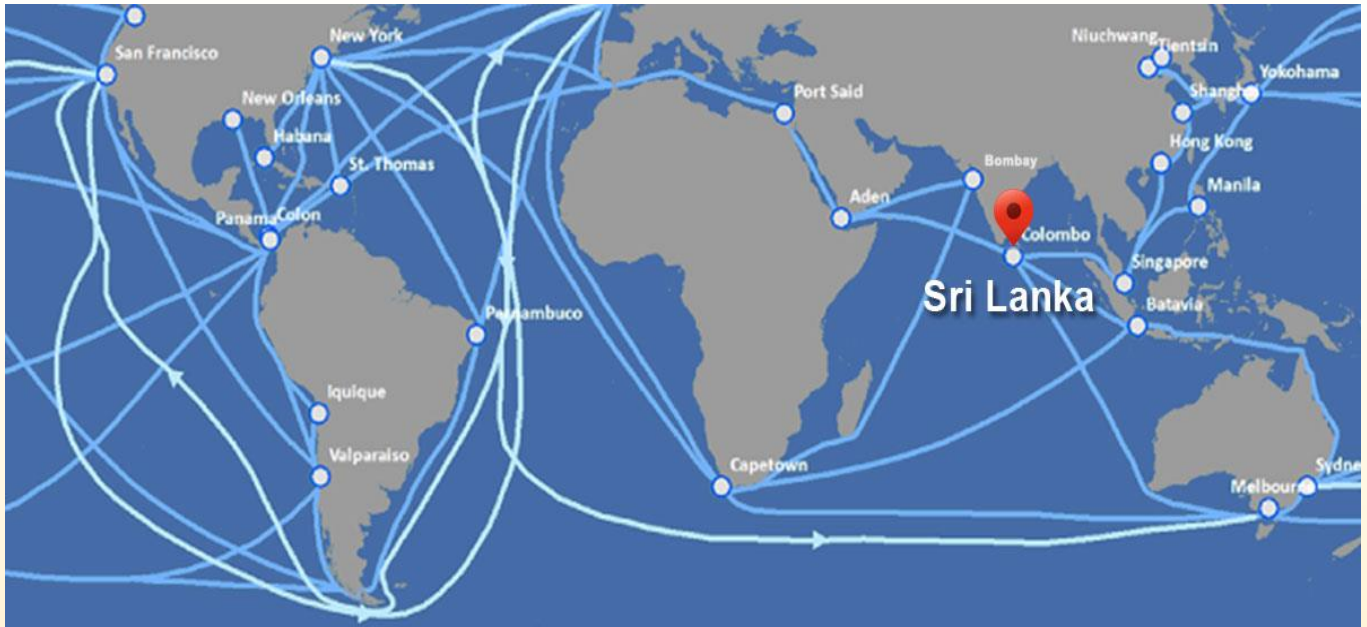

THE SERVICE – FREE PORT (BONDED STORAGE)

Hambanthota sea port in Deep South of Sri Lanka is the main sea port that is dedicated to provide all range of shipping and related services for Auto Logistics that be defined as a strategic hub to international ports of call. The recently inaugurated Hambanthota Int'l Airport is in close proximity to Sea Port in Hambanthota. This would enable and facilitate our country in providing logistics solutions within air freighting of Automobile's, spare parts, accessories, machineries and manpower tools.

- Having combined facilities in the sea port and airport in deep south of Sri Lanka, we are pleased to offer below extended facilities for our customers who are engage in vehicle manufacturing , Trading and exporting internationally.
- Promote and Facilitate the Import of Automobiles to Hambantota sea port and store up to 6 months for the purpose of re- export. A Customs Bonded land area has been allocated for this purpose.
- Under this facility any automobile importer trans-ship any type automobile while using the Bonded Storage up to a period of 6 months (180 Days). Thereafter export to any destination as per demand.
- Since this service operates as part of a free port facility all charges are exempted from customs duties at the point they are re-exported.

PROCEDURE OF IMPORT AND RE-EXPORT

- Whenever a client has a requirement to trans-ship via using the Customs Bonded Storage facility in the Hambantota Port, place freight booking with our counterpart Sync Logistics Inc., Japan and they will do the needful to export vehicles by arranging export customs clearing , shipping , documentation, Vehicle Inspections , freight up to Hambantota Port.
- Bill of lading will be issued for the exported vehicle keeping ownership of the vehicle to the exporter.
- Vehicles will be consigned under the name of port operator (Clarion Logistics Pvt Ltd).
- When Exporting Bill of lading will be issued to shipper as an absolute owner of the vehicle as the exporter and the consignee will be the buyer of the vehicle in other destination.
- Upon arrival of the vehicles to Hambantota port, Clarion Logistics Pvt Ltd will submit freight manifest to Sri Lanka customs and ports authority to discharge vehicles as transshipments and transfer to storage facility.
- Depend on customers requirement vehicles will be stored and kept up to 180 days from the date of arrival and during this period customer will have to find the buyer to export to next destination.
- Once the ultimate buyer and destination is arranged by the customer, Clarion Logistics, will book the freight from Hambantota and complete export customs and documentation formalities to ship vehicles.
- **If customer fail to export the vehicle from Hambantota will arrange to re-export to the country it originated at the cost of the customer.**

Financial Proposal (Bonded Storage)

Units 100 or below

Storing and Handling a vehicle from Vessel to Yard and store 1 to 90 days	USD 100.00 Per Unit
From 91 st day to 180 th Day	USD 15.00 Per every 30 days.
Port Storage Charges	USD 0.75 Per Vehicle Per Day

If the number of vehicles are higher storage rate will apply as below.

400 Vehicles	USD 50.00 per Vehicle
300 Vehicles	USD 65.00 per Vehicle
200 Vehicles	USD 85.00 per Vehicle

Since Automobiles are exported to different destinations ocean freight will be offered on case by case basis to customers. Freight will be arranged either by Roll in Roll out vessels or in container vessels depend on the destination the no of vehicles that would be exported. However if the customers are having an idea of the final destination or destinations vehicles will be exported Via Hambantota and freight quotation could be offered for budgetary purpose.

Example

If customer send a sedan car which is about 10M3 to store for a period of 4 months and export to Durban cost would be as below.

Total Cost on storing 4 months and export to Durban	605.00
